a) Petitioned Warrant Article Related to Land Use and Development

Discussion of proposed amendment to Article 2, <u>Districts and District Regulations</u>, Section 2440 (D7), <u>Medical Marijuana Treatment Center</u>, of the Zoning By-Laws to prohibit MMTCs from the Res 3 and Res B Zoning Districts where they are currently allowed by Special Permit from the Planning Board (STM Warrant Article 1).

There was a motion by Steven Baker to recommend Article 2, to amend the definition of "Natural Grade", with the revision that the second means of determining natural grade is eliminated. Brandon Quesnell seconded. VOTE: 3-0-0.

c) Proposed Zoning By-Law Amendment

Discussion of proposed amendment to Article 2, <u>Districts and District Regulations</u>, Section 2550, <u>Surveys</u>, of the Zoning By-Laws to add a requirement for height and foundation surveys (STM Warrant Article 3).

Ms. McPherson reviewed the proposed Article. The Board discussed it.

There was a motion by Steven Baker to recommend Article 3, a proposed amendment to Article 2, <u>Districts and District Regulations</u>, Section 2550, <u>Surveys</u>, of the Zoning By-Laws to add a requirement for height and foundation surveys. Brandon Quesnell seconded. VOTE: 3-0-0.
