### **Regulation Changes**

#### **10.00 RENTAL OR LEASE OF BICYCLES AND MOTORIZED BICYCLES AND SCOOTERS**

##### **10.01 Rental or Lease of Bicycles**

No person, business or corporation shall engage in the business of renting, leasing or keeping for rent or lease any bicycles, without first being licensed by the Licensing Board in accordance with the following regulations:

- a. Application for a license under this by-law shall be filed with the Licensing Board and contain the following information:
  1. Proof of worker's compensation insurance and general liability insurance;
  2. Proposed total numbers of bicycles offered for rent or lease;
- b. Each licensee shall be required to affix a bike light to each bicycle, and shall provide a helmet to all riders 16 and under.
- c. Licenses shall expire on December 31st of each year, and are required to be renewed before expiration for the following year before any rental activity may commence.
- d. Each licensee shall comply with Chapter 85 sec. 11B of the General Laws and any amendments thereto, any other statute, or any Town by-law and/or regulation.
