CS said that she felt what Mr. Hobart is currently doing is working fine, suggested perhaps a stronger measure to business owners who aren't in compliance with the guidelines for the reported second incidence. BS said she totally trusted Mr. Hobart's guidance. RD said he agreed with CS in that handing out pamphlets could be helpful in educating the public, adding that we are all in this together, but a second occurrence could warrant a stronger reply. SB agreed with all the comments made and concurred that we are all in this together.
