## October 21, 2020

The Provincetown Historic District Commission will hold a Public Hearing at 4:00 P.M. on Wednesday, October 21, 2020, in the Judge Welsh Room at Town Hall, 260 Commercial Street, Provincetown, MA.

Public Hearings will be held for the following applications requesting a Certificate to be issued in accordance with the Provincetown Historic District Commission established under the General By-Laws, Chapter 15 of the Town of Provincetown.

Application by **Brian Dennison**, on behalf of **Ken Pratt**, requesting to replace 4 windows and an entry door on the structure located at **38 Bradford Street, U1**.

### **HDC 20-2042**

Application by **Lisa West** requesting to replace 2 windows and to replace a bay window with a 90-degree bump-out containing 3 windows on the structure located at **5 Brewster Street, U1**.

### **HDC 20-2047**

Application by **Cass Benson** requesting to replace a set of stairs on the structure located at **6 Johnson Street**.
