Susan move to accept minutes from 06.09/2021 as corrected. John 2nd. Vote Unanimous

John move to take Staff Liaison out of order. David G 2nd Vote 4-1-0

Don- PWC Updated current bylaws on the website with language "legal speed"
Marcello Subashi PWC presentation for possible set up on the pier. Described his plan with 4 PWC's total, 3 rental and 1 guide. A GPS system will control speed remotely to ensure safety. Discussion ensued. Jamie stated the pier corp had a chapter 91 question about use of the pier by the PWC business.

Susan wants the Harbormaster to regulate the speed in the channel. Marcello indicated they will obey speed and boat regulations. The trips will be 55 minutes long for \$175 from 9-5.

Public Statements: None

Jim Vincent: Update on Chapter 91 approximately 105 properties on tidelands, 95 are private 120 are licensed. Our job is compliance and education. He hopes for in person training in September for 2-3 hours.

David G-Town Landing signs-working on amending and finishing them.

Blue Economy signs QR codes-Detailed info is coming. West End Parking Lot sign-Rex stated we are looking for new locations to present to Select Board.

John move to table it. David F 2nd. Discussion: Susan stated the Select Board wants alternative spots. Rex reminded us we were charged to consolidate signs with the Chamber and Harbor Committee. We should continue the project with Blue Economy to support Aquaculture for those who make a living on the water. He recommends the Pilgrim Landing Park area at the kayak rack at the rotary (not in the park)for its visibility of aquaculture, adding a bench where there are none and the educational component. Vote. 3-2-0

Laure move for Committee to support the location recommended by Rex not to exceed \$500 cost incurred from Harbor Access Gift Fund includes repositioning and any change in language. Elise 2nd vote 3-2-0

Pier Corp liaison: Services agreement renewal postponed 90days for review. They

approved the blue economy signs.

Don is now the official liaison to the Harbor Committee. Laura feels it is not the position for the Harbormaster. Their duties can not be performed while in meetings with us. The Harbor Committee should be represented by the Marine Coordinator (Rex's current job). The definition of the job was as liaison to Harbor Committee. David F stated Rex has 15 years experience in our Harbor and a relationship with the state. Our Harbor Plan guides us. David G welcomes Harbormaster as liaison. Don continued update.
