5. Member Updates: J. Santo brings up need for BEACH ACCESS signage on the street side of Johnson St., among other places. G. Binder agrees. Conversation about beach access ensues. D. Gluck adds that he will get the other half of the HC's beach access sign project going. S. Avellar brings up importance of Ch. 91 accessways. DEP's last visit to ptown was 2009. G. 6. Pier Corp. Liaison Report: Herbie Hintze has nothing to report.
7. Harbormaster Report: Harbormaster German. The 27 ft Columbia(?) still stuck on the rocks, waiting on updates. Owner uncooperative. M1 is out till next week, M3 will take its place/go for maintenance when M1 returns. 46 Chris Craft is getting weekly citations, DEP unresponsive. W. Loughlin concerned about both abandoned boats, concern over damage to shell-fishing, accountability if someone gets hurt. G. Binder: Another attractive nuisance. W. Loughlin adds that she witnessed house boats dumping waste, said it was reported not sure if anything was done about it. D. German says he will look into it. S. Avellar reports kayaks left on beachside of "east end" park.
8. West end boat ramp, Captain Jack's Wharf, east side of Macmillan Wharf, designated beached boat permits for dinghies, skiffs, not larger hobbycats and the like. D. German says" under 17 feet, follow rules as written. S. Avellar reports Kayaks left on beach side of "east end" park. , G. Binder adds: maybe from Swim for life event.
