Also attending: Robert Silva, Dan Cenotti and Staff Sgt. Robert Russell. A private club is allowed to have smoking inside, even with the smoking ban in place. With this privilege, the question of more business at the VFW to non-members had arisen. Non-members, "guests" are required to sign a ledger book before receiving an alcoholic beverage by a bartender (either VFW member, or VFW Auxiliary member). Ronald Pickard guaranteed the board that all guests were signing the book therefore no possible violations would occur from this concern.
