These plans outline funding priorities and serve as the strategic and planning documents for Barnstable County's HOME Program which is funded by the U. S. Department of Housing and Urban Development (HUD).

The Barnstable County HOME Consortium will conduct a public hearing on **Thursday, April 16, 2020 at 8:30 a.m. via a virtual meeting** pursuant to Massachusetts Governor Charles D. Baker's Order Suspending Certain Provisions of the Open Meeting Law dated March 12, 2020. **The proposed funding allocation from HUD for Program Year 2020 is \$462,217.**
