On October 20, 2021 at 4:15 p.m., the Assembly of Delegates will hold a virtual public hearing on Proposed Ordinance No. 21-15, to authorize a re-allocation of a capital expenditure for the repair of the Superior Courthouse roof, as authorized in Ordinance 17-05, to the repair of the Second District Court house roof in the amount of \$150,000.00

Proposed Ordinance 21- ____

To amend a Portion of Ordinance 17-05 adopted by a vote of the Assembly of Delegates on May 03, 2017 and approved by the Board of Regional Commissioners on May 10, 2017, by amending the "Superior Courthouse Roof" in Section 1(b) of Ordinance 17-05 to the amount of \$210,000 and adding "Second District Roof" in the amount of \$150,000, such the amended vote reads in its entirety as follows:

To authorize the County to purchase capital equipment, and implement capital improvements for use in conducting the business of the County and to borrow money to pay therefore;

Barnstable County hereby ordains:

The Board of Commissioners is hereby authorized to purchase capital equipment, and implement capital improvements for use in conducting the business of the County as follows:

Section 1.

a. Purchase the following equipment for the Health and Environment Department for use in conducting business specific to the operations and services of the Barnstable County Commissioners:

Section 2.

For the purposes set forth .in Section 1, the County Treasmer, with the approval of the County Commissioners, may borrow from time to time, on the credit of the County, such sums as may be necessary, and may issue bonds and or notes of the County therefore;


Section 3.

All bonds or notes issued pursuant to this proposed ordinance shall be signed by the County Treasurer and countersigned by a majority of the County Commissioners. The County may sell securities at public or private sale upon such terms and conditions as the County Commissioners may deem proper but not at prices of less than par value. Indebtedness incurred under this proposed ordinance shall, except as herein provided, be subject to Chapter 35 of the Massachusetts General laws.
