B. Requirements

This Scholarship may be awarded on an annual basis for up to four years of college, and two years of post-graduate study or professional school (i.e., six times per student).

- For those entering college as a freshman, the application deadline is May 15. If awarded, the Scholarship is paid after proof is received by the Committee of successful completion of the first semester. See the list below for what is required to prove successful completion.
- For students already in college or graduate or professional school, the application deadline is October 1. Applications must include proof of successful completion of the prior year. See the list below for what is required to prove successful completion.

C. Proof of successful completion requires submitting all of the following:

1. a **certified** transcript of all courses completed to date, _____

2. proof of tuition payment from the bursar's office for the period completed, _____

and

3. a statement from the School indicating that the student is continuing and has enrolled in the current/upcoming semester. _____

II. CAPTAIN JOSEPH F. OLIVER SCHOLARSHIP, established by the will of Captain Joseph F. Oliver

A. Eligibility

This Scholarship is available only to students who:

1. Resided at the time of graduation from high school in:
Provincetown _____ or Truro _____, and
2. Graduated from:
 - a. Provincetown High School in, or prior to, 2013 _____, or
 - b. A Cape Cod high school after 2013 _____, and
3. Who have successfully completed their first year of college. _____

B. Requirements

This Scholarship may be awarded on an annual basis for up to three years of college and two years of post-graduate study (i.e., up to five times per student).

For all students the application deadline is October 1. Applications must include proof of successful completion of the prior year. See the list below for what is required to prove successful completion.

C. Proof of successful completion requires submitting all of the following:

1. A **certified** transcript of all courses completed to date _____,
2. Proof of tuition payment from the Bursar's office for the period completed _____, and
3. A statement from the School indicating that the student is continuing and has enrolled in the current/upcoming semester. _____

III. TOWN SCHOLARSHIP, established by the Town of Provincetown.

A. Eligibility

This Scholarship will be awarded to a student entering their Freshman year of college who meets all of the following requirements:

1. Is a Provincetown resident _____,
2. Has achieved a distinguished academic record _____, and
3. Has included an essay of up to two hundred fifty words on the topic of the ways in which your college education will enable you to contribute to the future of Provincetown. _____

B. Requirements

The application deadline is June 1. If awarded, the Scholarship is paid upon approval. This is a one-time only Scholarship.
