Minutes of Tuesday, April 15, 2014**

Call to order: 5:25pm

Public comments:

A) None

Public hearing: To discuss and set fees for the 2014 Summer Program

Current Fees: Resident (\$300 for the entire summer)

Non-resident (\$65 per week)

Proposed Fees: Resident (\$325 for the summer)

Non-resident (\$75 per week)

The reason for increase is so that a t-shirt can be included with registration. Elisabeth discloses that she will be paying the fees for the Summer Program. David makes a motion to raise summer fees. Elisabeth seconds that motion. Motion approved.

New business:

A) American Lung Association – Application to use VMCC for event. Elisabeth recused herself because a possible conflict of interest. In addition to the Rec application, they also must fill out a town application to use the parking lot. Treg makes a motion to approve application. David seconds that motion. Motion approved.

B) East End Playground equipment – Some of the equipment needs to be upgraded as soon as possible so that resurfacing of the playground can be completed. Brandon hands out numbered photographs of new playground pieces. Treg makes a motion to add Option #3. Elisabeth seconds that motion. Motion approved.

Old Business:

A) Motta Field Tennis Court Application – Ken Ventimiglia (not in attendance) Brandon suggests putting up a new sign of the rules at the tennis courts and include a note that there are tennis lessons available through the Recreation Department. Ken would not be able to advertise at the courts (town property). Elisabeth makes a motion to deny the application. David seconds that motion. Motion approved.

B) Charter Review – Elisabeth reviews her suggestions and notes. Elisabeth asks if the Teen Center Sub Committee needs to be officially disbanded. Also, need to include the move to VMCC on schedule. Treg suggests a draft of changes before next meeting.

Director's Report:

A) Town meeting update – Town meeting was successful. The VMCC was approved to have AC in the entire building. Not sure when it will be installed.

Assistant Director's Report:

A) Mural update – The artists have started painting the new mural in the large rec room. It is a colorful underwater scene. The artists estimate that they will be completed in the next two months or so.

B) Easter Egg Hunt – Saturday, April 19th there will be an Egg Hunt held at the VMCC. The PTA will provide eggs, candy and snacks. The Rec Dept will provide staff and decorations.

C) Summer Food Service Program – The Summer Program will be offering free lunch to any kids that attend our program. The program is a federal program funded by Project Bread and Children's Nutrition Outreach Program. The meals are well-balanced and are delivered by the Church of the Holy Spirit each day. They will even be able to deliver the meals on field trip days.

Treg makes a motion to adjourn meeting, second by Tim Downey.
