The Provincetown Conservation Commission will hold a Public Hearing at 6:30 p.m. on **Tuesday, August 1, 2017** in the Judge Welsh Room, Town Hall, 260 Commercial Street, Provincetown, MA to consider the following requests:

### CON-18-005 **401 ½ Commercial Street**

Request for Determination of Applicability filed by David Gluck, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, for the installation of a seasonal kayak rack, adjacent to the Washington Ave. Town Landing. Work to take place within Coastal Beach and Land Subject to Coastal Storm Flowage.

### CON-18-006 **487 Commercial Street**

Notice of Intent filed by Pamela Cyr and Joyce Holupka, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, for replacement of existing wooden bulkhead with vinyl bulkhead. Work to take place within Land Subject to Coastal Storm Flowage and Buffer Zone to Coastal Beach.

### CON-18-007 **635 Commercial Street**

Notice of Intent filed by Shepard G. Schwartz, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, for protection of an existing concrete bulkhead by improving the concrete surface. Work to take place within Land Subject to Coastal Storm Flowage, Coastal Beach, and Buffer Zone to Coastal Beach.

### CON-18-009 **99 Commercial Street**

Request for Determination of Applicability filed by Siobhan Carew, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, for the construction of a pile-supported deck. Work to take place within Land Subject to Coastal Storm Flowage, Coastal Beach, and Buffer Zone to Coastal Beach.
