Request for Determination of Applicability filed by Hal Z. Katzen, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, for the construction of an approximately 70 square-foot addition to the southwest corner of the existing structure and a dormer, and replace some windows and doors, roof, sidewall shingles, and trim. Work to take place within Land Subject to Coastal Storm Flowage and Buffer Zone to Isolated Vegetated Wetland
