Request for Determination of Applicability filed by Joseph and Jane Taves, pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s. 40) and the Provincetown General Bylaws Chapter 12, Wetlands Protection Bylaw, to construct access steps, set into grade, from street side of property into rear yard, through existing retaining wall. Work to take place within Bordering Land Subject to Flooding and Buffer Zone to Pond and Bordering Vegetated Wetland.
