Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 23, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the **Open Space Committee** will be conducted via remote participation to the greatest extent possible. - g) Plan tree planting event – Spring 2021.
- h) Spring 2021 Annual Town Meeting warrant - 668R Commercial Street.

- j) Stewardship/maintenance issues.
