Shellfish Constable Report;

Recreational Shellfishing Season 2021-22:

- On September 27, 2021 the Select Board voted to approve opening the following area: Subject to testing, the area labeled on maps as East of the Breakwater—Area located directly to the east of the Provincetown breakwater, will be open to the public for recreational shellfishing on Fridays and Sundays beginning Friday, November 5, 2021 and ending Sunday, March 27, 2021 (see attached map)
- Testing of contaminated transplanted oysters from the Johnson St. resource has been completed and the animals are safe for consumption (see attached notice from MA DMF)

In accordance with Chapter 130, Section 74A of the Massachusetts General Laws, the Division of Marine Fisheries has examined the oysters transplanted from Provincetown Harbor to the east side of the Breakwater in Provincetown Harbor (CCB:4.21) under permit #161542. As a result of this examination, the Division has determined that this area, closed by Marine Fisheries on June 10, 2021 now meets the requirements for harvest of shellfish and has changed the status of the area to "OPEN TO SHELLFISH-ING" as of sunrise on October 5, 2021.

The below defined area may be opened to the harvest of shellfish for direct human consumption subject to local rules and regulations under authority of Massachusetts General Laws Chapter 130, Section 52.

New Business:

Review of Regulations for Aquaculture; Steps required to eliminate \$25/A fee and requirements to prevent bird contamination on floating gear were discussed by Shellfish constable. **Motion** by W. Loughlin, second by W. Loughlin to remove item 8 and item 28b from regulations and to not require any non-billed acre fee to be paid. **Vote 3-0-4 approve.** 4 members abstained as they are grant holders.

Any other new Business:

• K. Chute presented her experience as a new grower; experimented with bottom, floating and cylindrical growing cages. With guidance from shellfish constable for process have harvested and sold oyster crops. Like close to west end parking lot. Also described a grant; working with artist (w/ marine biology degree) to portray scenes of working an oyster grant. This will be displayed at Provincetown library in December.

- M. Chute described an interactive internet method he is working on to provide visitors with live or video visitor access tours of shellfish acqulture. This will include area views via drone.
- It was mentioned that a Sailboat (approx. 28ft) ran into west end break water six weeks ago. Ownership as not been established for removal and salvage responsibility. Possible leakage of fuel or sanitary tank fluids could contaminate proposed recreational shellfish area causing the area to be closed. This issue will be presented to the Harbor Committee
- S. Wisbauer commented on dogs in acquiture area. Dogs belonging to growers are no allowed on boats or in areas where shellfish are being harvested or handled. Dog belonging to general public are allowed in the area but should not be permitted to directly contaminate shellfish. Constable offered to go to dog committee with shellfish representative to resolve problem in area.
