The Health Agent, Jane Evans discussed the pumping of grease traps and the problems that can occur when a restaurant does not pump their grease trap regularly. Ms. Evans showed pictures of a grease trap that was not pumped and recommended that it be mandatory for all restaurant owners and/or managers to attend a 1-hour class regarding grease and that prior to receiving licenses, licensees must give proof of pumping. The Licensing Board was in full support and asked Ms. Evans to put together the regulation to be incorporated into the Licensing Board Rules & Regulations.

Linda Ersoy of WayDownTown states that there has been some confusion as to what restaurant owners were to do with regard to grease traps and agrees that there should be clear guidelines set up.
