Minutes – November 9, 2010

Continue to December 14 meeting.

Old business – discussion with Raphael Richter of Mercedes Cab Co. regarding issues occurring over the summer. Mr. Richter addresses the board and states that hailed fares have significantly increased. Mercedes has six taxis total. Next year, the number of vehicles will increase to seven or eight taxis and four livery, plus two buses, funk van and limo. Mr. Richter also addresses and denies allegations that a passenger was over charged and forced to pay gratuity. Regarding the claims that Mercedes Cabs conditions are poor, Mr. Richter states that he has two, full-time maintenance people to keep up with the mechanics and that the vehicles are vacuumed and cleaned twice daily. He will, however, try to keep cleaner. Kristin C. Hatch states that she understands that with more cabs, there are going to be more complaints. Cleanliness is important as well as giving employees courtesy training – informing them of the difference between a taxi and livery vehicles and where they can and can't stand. If everyone does not adhere to the laws, it will make it hard to grow the business. Ms. Hatch agrees with Mr. Richter that the number of taxis in town should be limited. That can be looked at in a future meeting. Raphael Richter asks what is considered too many complaints. AJ Petras states that it is the responsibility of the board to make sure laws are enforced and to deal with them in a timely fashion.

New Business – Extension of hours for NYE until 2AM - Harbor Lounge, Enzo

Motion to continue approval of extension of hours on NYE for Harbor Lounge by Kristin C. Hatch. Seconded by George Young. Unanimous 5-0.

Motion to approve extension of hours on NYE for Enzo by AJ Petras. Seconded by Kristin C. Hatch. Approved 5-0.

Discussion ensued regarding grease trap pumping. Proof of pumping needed by January 1, 2011. Board of Health should be responsible for levying a fine. The Licensing Board could have a show-cause hearing for suspension of license if necessary.

Motion to notify Jane Evans of non-compliant grease trap pumping and approved licenses and to hold licenses of non-compliant pumpers until clearance is received by Board of Health by AJ Petras. Seconded by George Young. Approved 5-0.
